As established by Law nº 5.648 of december 11, 1970, this is the official publication of the National Institute of Industrial Property, an office under the Ministry of Economy, Federative Republic of Brazil, which publishes all its official acts, orders and decisions regarding the industrial property system in Brazil, comprising Trademarks and Patents, as well as those referring to Technology Transfer agreements and related matters, besides those regarding software registering as copyright.
