RESOLVEM:

Art. 1º O artigo 19 da Portaria INPI/PR nº 08, de 17 de janeiro de 2022 passa a vigorar com a seguinte redação:

- IX – pedidos de registro de marcas tridimensionais;
- X – pedidos de registro de marcas tridimensionais designados ao Brasil pelo Protocolo de Madri;
- XI – pedidos de registro de marcas de posição;

XII – pedidos de registro de marcas de posição designados ao Brasil pelo Protocolo de Madri.”

Art. 2º Fica revogado o artigo 30 da Portaria INPI/PR nº 08, de 17 de janeiro de 2022.
